#### HOME EQUITY LOAN REQUIREMENTS:

Minimum loan amount is \$10,000 and maximum loan amount is \$250,000.

#### TERMS OF REPAYMENT:

Five-Year Draw/10-Year Amortization Variable-Rate Home Equity Line of Credit Example: The information provided assumes the purpose of the loan is to cash out on the primary residence, with a loan amount of \$50,000.00. At a 8.000% interest rate, the APR for this loan type is 8.000%. The monthly principal and interest payment would be 119 payments of \$606.64 and one payment of \$606.20.

Five-Year Draw/10-Year Amortization Fixed-Rate Home Equity Line of Credit Example: The information provided assumes the purpose of the loan is to cash out on the primary residence, with a loan amount of \$50,000.00. At a 5.875% interest rate, the APR for this loan type is 5.875%. The monthly principal and interest payment would be 119 payments of \$551.97 and one payment of \$551.76.
