Minimum loan amount is \$10,000 and maximum loan amount is \$250,000.

TERMS OF REPAYMENT:

Five-Year Draw/10-Year Amortization Variable-Rate Home Equity Line of Credit Example: The information provided assumes the purpose of the loan is to cash out on the primary residence, with a loan amount of \$50,000.00. At a 4.00% interest rate, the APR for this loan type is 4.00%. The monthly principal and interest payment would be 119 payments of \$ 506.23 and one payment of \$ 505.58.

Five-Year Draw/10-Year Amortization Fixed-Rate Home Equity Line of Credit Example: The information provided assumes the purpose of the loan is to cash out on the primary residence, with a loan amount of \$50,000.00. At a 4.99% interest rate, the APR for this loan type is 4.99%. The monthly principal and interest payment would be 119 payments of \$533.53 and one payment of \$ 532.21.
