

**AMERICAN AIRLINES FEDERAL CREDIT UNION
“WIN \$2K FOR THE HOLIDAYS” OFFICIAL RULES**

NO PURCHASE OR PAYMENT OF ANY KIND IS NECESSARY TO ENTER OR WIN THIS CONTEST. THIS CONTEST IS INTENDED FOR VIEWING IN THE UNITED STATES ONLY AND SHALL ONLY BE CONSTRUED AND EVALUATED ACCORDING TO UNITED STATES LAW. VOID WHERE PROHIBITED.

Sponsor: The “Win \$2k for the Holidays” (“Contest”) is sponsored by American Airlines Federal Credit Union (“Credit Union”) (“Sponsor”), whose business address is MD 2100, P.O. Box 619001, DFW Airport, TX 75261-9001.

Eligibility: Contest is open to all legal residents of the fifty (50) United States who are Credit Union members in good standing, who are eighteen (18) years of age or older. Officers, contractors, directors, officials, committee members and employees of the Sponsor; and any of their respective parent companies, affiliates, franchisees, licensees, subsidiaries, advertising/promotion agencies, persons engaged in the development, production or distribution of materials for this Contest (collectively, the “Released Parties”) are not eligible to participate in the Contest. Sponsor reserves the right to verify eligibility qualifications of any winners. The Contest is subject to all applicable federal, state and local laws and regulations. Participation constitutes entrant's full and unconditional agreement to these Official Rules and Sponsor decisions, which are final and binding in all matters related to the Contest. Winning a prize is contingent upon fulfilling all requirements listed below. Void in Puerto Rico, the U.S. Virgin Islands, Guam, U.S. Military installations in foreign countries and where prohibited, taxed or restricted by law.

To Enter: There are two ways to enter the Contest. Between October 1, 2021 and November 30, 2021 (“Promotion Period”), use your Credit Union debit card and/or credit card. Every one (1) purchase from your Credit Union debit or credit card that posts to your account during the Promotion Period will give you one (1) entry in the Contest, up to a maximum of 1,000 entries. Total purchases will be tallied by Sponsor and will be net of refunds and/or returns. ATM withdrawals and cash advances are not eligible. Alternatively, you can submit up to five (5) entries by sending a 3x5 note card with your complete name, address, city, state, zip, telephone number and valid email address to the following address which must be postmarked (by USPS) no later than 11:59 p.m. CST on November 15, 2021. Drawing: Two (2) random drawings will be conducted from among all eligible entries received by Sponsor by the specified deadline: two (2) winners from the debit card entries and two (2) winners from the credit card entries, for a total of four (4) winners. The drawing will take place no later than December 15, 2021. Winners need not be present to win and will be notified by phone and/or email. If a winner cannot be contacted within five (5) business days of the initial contact date, the prize will be

forfeited and awarded to an alternate winner. The winners will be required to sign an affidavit of eligibility which must be completed, signed and returned within five (5) business days from the date of issuance, or the prize will be forfeited and awarded to an alternate winner. Any bonuses or monies received in association with this promotion are subject to IRS reporting requirements. Recipients are responsible for any income tax liability, if applicable.

Prize: A total of four (4) prize winners will randomly be selected from all valid entries received: two (2) winners from the debit card entries and two (2) winners from the credit card entries. Each winner will have Two Thousand Dollars (\$2,000.00) ("Prize") credited into their Credit Union regular share account. The maximum amount to be awarded is Four Thousand Dollars (\$4,000.00) per entrant. The total prize amounts to be awarded is Eight Thousand Dollars (\$8,000.00).

Prizes will be deposited within thirty (30) days after receipt of a signed affidavit of eligibility. Except where prohibited, acceptance of a Prize constitutes winner's consent to use of his/her name and/or photograph without further compensation for advertising, promotional use and publicity by Sponsor. By accepting a Prize, winner acknowledges compliance with these official rules. Prize is non-transferrable and cannot be substituted for cash.

Odds: Odds of winning depend on the total number of eligible entries received.

Release: By accepting the Prize, winners agree to release and hold harmless Sponsor and Released Parties from and against any claim or cause of action arising out of participation in the promotion or receipt or misuse of any Prize.

Recipients are responsible for income tax liability if applicable. Sponsor reserves the right, at its sole discretion, to cancel, terminate, modify or suspend this Contest or any portion hereof, or to disqualify any individual implicated in any of the following actions, if for any reason: (a) tampering, unauthorized intervention, actions by entrants, fraud, technical failures, or any other causes which, in Sponsor's

sole opinion, corrupt or affect the administration, security, fairness, integrity or proper conduct of the Contest, or (b) the Contest is otherwise not capable of running as planned by Sponsor.

Disputes: As a condition of participating in this Contest, participant agrees that any and all disputes which cannot be resolved between the parties, and causes of action arising out of or connected with this Contest, shall be resolved individually, without resort to any form of class action, exclusively, before a court located in the County of Tarrant, State of Texas having competent jurisdiction, which court shall apply the laws of the State of Texas without regard to its conflict of law provisions. Further, in any such dispute, under no circumstances will participant be permitted to obtain awards for, and hereby waives all rights to claim punitive, incidental or consequential damages, or any other damages, including attorneys' fees, other than participant's actual out-of-pocket expenses (i.e. costs associated with entering this Contest), and participant further waives all rights to have damages multiplied or increased.
