HOME EQUITY LOAN REQUIREMENTS:

Minimum loan amount is \$10,000 and maximum loan amount is \$250,000.

TERMS OF REPAYMENT:

Five-Year Draw/10-Year Amortization Variable-Rate Home Equity Line of Credit Example: The information provided assumes the purpose of the loan is to cash out on the primary residence, with a loan amount of \$50,000.00. At a 7.25% interest rate, the APR for this loan type is 7.25%. The monthly principal and interest payment would be 119 payments of \$ 587.01 and one payment of \$ 586.19.

Five-Year Draw/10-Year Amortization Fixed-Rate Home Equity Line of Credit Example: The information provided assumes the purpose of the loan is to cash out on the primary residence, with a loan amount of \$50,000.00. At a 5.24% interest rate, the APR for this loan type is 5.62%. The monthly principal and interest payment would be 119 payments of \$ 545.74 and one payment of \$ 544.79.
