## American Airlines Federal Credit Union "85<sup>th</sup> Anniversary Contest" Official Rules

NO PURCHASE OR PAYMENT OF ANY KIND IS NECESSARY TO ENTER OR WIN THIS CONTEST. PURCHASE OR PAYMENT OF ANY KIND WILL NOT INCREASE YOUR CHANCES OF WINNING. THIS CONTEST IS INTENDED FOR VIEWING IN THE UNITED STATES ONLY AND SHALL ONLY BE CONSTRUED AND EVALUATED ACCORDING TO UNITED STATES LAW. VOID WHERE PROHIBITED.

**I. CONTEST PERIOD:** The "85<sup>th</sup> Anniversary Contest" (the "Contest") begins at 12:00:00 a.m. midnight Central Time ("CT") on 05/01/2021 and ends at 11:59:59 p.m. CT on 08/31/2021(the "Promotion Period"). Additionally, the months of May 2021, June 2021, July 2021 and August 2021 may also be referred to as the "Anniversary Promotional Entry Period." The Contest is sponsored by American Airlines Federal Credit Union ("Credit Union"), MD 2100, PO Box 619001, DFW Airport, TX 75261-9001 (the "Sponsor"). The official clock for purposes of the Contest is the computer of the Sponsor.

**II. ELIGIBILITY:** The Contest is open to all legal residents of the fifty (50) United States who are Credit Union members in good standing, who are eighteen (18) years of age or older and who have completed one or more entry points during the Promotion Period.

fficers, contractors, directors, officials, committee members and employees of the Sponsor; and any of their respective parent companies, affiliates, franchisees, licensees, subsidiaries, advertising/promotion agencies, persons engaged in the development, production or distribution of materials for this Contest (collectively, the "Released Parties") are not eligible to participate in the Contest. The Contest is subject to all applicable federal, state and local laws and regulations. Participation constitutes entrant's full and unconditional agreement to these Official Rules and Sponsor decisions, which are final and binding in all matters related to the Contest. Winning a prize is contingent upon fulfilling all requirements listed below. Void in Puerto Rico, the U.S. Virgin Islands, Guam, U.S. Military installations in foreign countries and where prohibited, taxed or restricted by law.

**III. HOW TO ENTER THE CONTEST:** An individual will be deemed a participant ("Participant") in the Contest if the individual has completed one of the following entry points during the Promotion Period.

- 1) Enrolled in direct deposit to your Credit Union checking account with a minimum deposit of Two Hundred Fifty dollars (\$250.00) per month;
- 2) Downloaded the Credit Union's mobile app;

- 3) Signed up to receive online statements in online banking;
- 4) Enrolled in SavvyMoney (credit monitoring)
  - Log in to your account through online banking or your mobile app.
  - Once there, click on "Financial Wellness" then "Credit Score and Report" to sign up today.
- 5) Enrolled in the Financial Wellness Navigator program at Navigator.AACreditunion.org; or,
- 6) Visit AACreditUnion.org/contest (the "Website") and follow the prompts and instructions to complete the registration information process. Participants will need to provide the following information: first name, last name, mailing address, city, state, ZIP code, phone number, email address, employer's name and job title. In addition, to be eligible for a First Place prize, the Participant must complete the Sharing field (in 100 words or less) with a short story ("Story") describing "Sharing Is Caring." By submitting an entry, Participant warrants that the Story (a) does not infringe any copyright, (b) does not invade anyone's privacy, (c) does not libel or slander anyone, (d) does not discuss behavior inappropriate for a general audience (including discussing unsafe actions or actions that may result in personal injury or destruction of property), (e) does not discuss the use of firearms, alcohol, nudity, or anything not legal in all 50 states, and (6) is original and has not previously been published. An original is the product of one's own mind and is not a copy or imitation. Any entry that does not meet this criteria will be disqualified.

Each completed entry point is equivalent to one (1) entry during the Promotion Period to be entered into a random drawing to win Eighty-Five dollars (\$85.00), First Place Prize. There is a limit of six (6) entries per person during the Promotion Period for the First Place Prize.

Every Participant who has completed four (4) entry points will receive one (1) entry towards the Grand Prize drawing of Eight Hundred Fifty dollars (\$850.00). After the Anniversary Promotional Entry Period closes for each month of May 2021, June 2021 and July 2021, a Sponsor representative will randomly draw twenty-one (21) First Place winners from all eligible entries received by Sponsor. For the Anniversary Promotional Entry Period that closes at the end of August 2021, a Sponsor representative will randomly draw twenty-two (22) First Place winners from all eligible entries received by Sponsor. Additionally, a Sponsor representative will randomly draw eight (8) Grand Prize winners from among all eligible entries received by Sponsor on or before 09/30/2021. If a winner cannot be contacted within five (5) business days of the initial contact date, the prize will be forfeited and awarded to an alternate winner. The winners will be required to sign an affidavit of eligibility which must be completed, signed and returned within five (5) business days from the date of issuance, or the prize will be forfeited and awarded to an alternate winner. The information that you provide in connection with the entry process will be used by Sponsor only, and will not be sold or provided to another company. You will remain eligible for this Contest whether or not you opt-in to receive promotional emails from the Sponsor and will have the ability to opt-out of receiving future promotional emails by clicking on the link contained in the most recent promotional email received.

V. LIMITATIONS OF LIABILITY: If for any reason this Contest is not capable of running as planned for any reason, including, without limitation, due to infection by computer virus, worms, bugs, tampering, unauthorized intervention, fraud, technical failures, fire, flood, storm, or other natural disaster, pandemic, riot, strike, civil commotion, government regulation, or any other causes beyond the control of the Sponsor which corrupts or affects the administration, security, fairness, integrity or proper conduct of this Contest (or any part of it), the Sponsor reserves the right, in its sole discretion, to disqualify any individual who tampers with the entry process, and to terminate, modify or suspend the Contest, in whole or in part, at any time, without notice and award the prize(s) using all non-suspect eligible entries received as of or after (if applicable) this termination or suspension date. Released Parties assume no responsibility for any incomplete, incorrect, or inaccurate information, whether caused by website users, tampering, hacking, or by any of the equipment or programming associated with or used in the Contest or by any technical or human error. Released Parties assume no responsibility for any error, omission, interruption, deletion, defect, delay in operation or transmission, communications line failure, theft or destruction or unauthorized access to, or alteration of, entries. VI. PRIZES: There will be twenty-one (21) First Place prizes available to be awarded for this Contest during each month of June 2021, July 2021 and August 2021. There will be twenty-two (22) First Place prizes available to be awarded for this Contest in September 2021. t. Each First Place prize winner will receive Eighty-Five dollars (\$85.00) to be deposited into their primary share account. There will be eight (8) Grand prizes available to be awarded for this Contest. Each Grand Prize winner will receive Eight Hundred Fifty dollars (\$850.00) and the funds will be deposited to their Primary Share Account. The total prize amounts to be awarded is Fourteen Thousand Twenty-Five dollars (\$14,025.00).

**VII. PRIZE WINNER SELECTION:** A total of eight-five (85) First Place prize winners will be randomly selected on or about the 15th of the following month from all valid entries received as of the last day of the respective month. Eight (8) Grand Prize winners will be randomly select on or about the 15<sup>th</sup> of the following month from all valid entries received as of 08/31/2021. If Sponsor determines that more prize claims are submitted or more prize notices are

distributed than the number of prizes offered in these Official Rules, Sponsor shall immediately suspend all drawings and prize awards, and Sponsor reserves the right to award any remaining prizes (up to the total set forth in these Official Rules) in a manner deemed fair and equitable by Sponsor. For example, Sponsor may select a winner in a random drawing from among the eligible entries received up to the time of the impairment or conducted a random drawing among all prize claimants, and the Sponsor nor any of the Released Parties shall have any further liability to any entrant in connection with the Contest.
