“90th Anniversary Sweepstakes”  
Official Rules**

**NO PURCHASE OR PAYMENT OF ANY KIND IS NECESSARY TO ENTER OR WIN THIS DRAWING. PURCHASE OR PAYMENT OF ANY KIND WILL NOT INCREASE YOUR CHANCES OF WINNING. **I. DRAWING PERIOD:** The “90th Anniversary Sweepstakes” (the “Drawing”) begins at 12:00:00 a.m. midnight Central Time (“CT”) on April 01, 2026, and ends at 11:59:59 p.m. CT on Sep. 30, 2026 (the “Promotion Period”). The Drawing is sponsored by American Airlines Federal Credit Union (“Credit Union”), MD 2100, P.O. Box 619001, DFW Airport, TX 75261-9001 (the “Sponsor”). The official clock for purposes of the Drawing is the computer of the Sponsor.

**II. ELIGIBILITY:** The Drawing is open to all legal consumer residents of the fifty (50) United States and residents of the District of Columbia who are Credit Union members in good standing and who are eighteen (18) years of age or older. Officers, contractors, directors, officials, committee members, representatives, agents, family members of employees of the Sponsor, and employees of the Sponsor; and those of Sponsor’s respective licensees, advertising/promotion agencies, and persons engaged in the development, production or distribution of materials for this Drawing (collectively, the “Released Parties”) are not eligible to participate in the Drawing. The Drawing is subject to all applicable federal, state and local laws and regulations. Participation constitutes entrant’s (also referred to as “Participant,” “you,” and “your”) full and unconditional agreement to these Official Rules and Sponsor decisions, which are final and binding in all matters related to the Drawing. Winning a prize is contingent upon fulfilling all requirements listed below. **Void in Puerto Rico, the U.S. Virgin Islands, Guam, U.S. military installations in foreign countries and where prohibited, taxed or restricted by law.**

**III. HOW TO ENTER THE DRAWING:** An individual will be deemed a Participant in the Drawing if the individual electronically registers during the Promotion Period and uses their credit or debit card or enters by the alternative method during the Promotion Period.

To Enter: There are two ways to enter the Drawing. First, during the Promotion Period, electronically register via the advertised website and use their credit or debit card. One electronic entry per Participant, submitting multiple entries does not increase chance to win. Participants can receive additional entries for every one product or service with your Credit Union membership opened by Sep. 30, 2026, up to a maximum of 50 entries. Products and services that qualify for

additional entries are: direct deposit of \$250, online banking user, mobile app user, enrolled in online statements, set Debt-to-Income(DTI) in credit monitoring, review or update contact information in online banking, accept terms and conditions in the Budget & Spending Hub in online banking, have an Emergency Fund, auto loan, Home Equity Line of Credit (HELOC), mortgage, personal loan student loan, checking account and a share certificate. Participants can also receive additional entries by using their credit card nine (9) times in a month for up to six months (6 entries), using their debit card nine (9) times in a month for up to six months (6 entries), using their digital wallet once a month for 6 months (6 entries), attend a Financial Wellness webinar, and Refer-a-member (10 entries).

Second, you may also enter by sending a 3" by 5" notecard with your complete name, address, city, state, ZIP code, phone number and valid email address to the following address, which must be postmarked (by U.S.P.S.) no later than 11:59 p.m. CT on Sep. 30, 2026. Limit to a total of 50 mailed in entries. Each mail entry must be mailed separately. A Participant is eligible to win only one (1) prize in the Drawing. All required information must be completed to enter and to be eligible to win. Incomplete entries will be disqualified. Sponsor reserves the right, in its sole discretion, to void any and all entries of a Participant who submits more than the stated maximum limit of entries by using multiple/different addresses, identities or any other methods, or whom Sponsor believes has attempted to tamper with, influence or impair the administration, security, fairness or proper play of this Drawing. Proof of entering information is not considered proof of delivery to or receipt by Sponsor of an entry. The use of automated entry devices is prohibited and no mechanically reproduced entries are allowed; all such entries are void. Released Parties are not responsible for lost, late, stolen, incomplete, illegible, incorrect, damaged, delayed, garbled, undelivered, postage-due, or misdirected entries, which will be disqualified. All entries become the exclusive property of Sponsor and will not be acknowledged or returned.

**IV. PERSONAL INFORMATION/OPT-IN:** Participants are providing their information to Sponsor and not to any other entity. By entering the Drawing, you consent for the Sponsor to obtain and use your name, address and other information ("Personal Information") for the purpose of administering this Drawing and such Personal Information will be kept by Sponsor for marketing purposes in accordance with its privacy policy ([AACreditUnion.org/globalassets/documents/privacy-notice.pdf](https://AACreditUnion.org/globalassets/documents/privacy-notice.pdf)), as posted on our website at [AACreditUnion.org](https://AACreditUnion.org) ("Website"). The information that you provide in connection with the entry process will be used by Sponsor only. You will remain eligible for this Drawing whether or not you opt in to receive promotional

emails from the Sponsor and will have the ability to opt out of receiving future promotional emails by clicking on the link contained in the most recent promotional email received.

**V. PRIZES:** There will be nine (9) prizes available to be awarded for this Drawing. Each Prize Winner will receive ten thousand U.S. dollars (\$10,000) to be deposited into their Credit Union primary share account (S0000) approximately 30 days after the Prize Winner has been confirmed. The total prize amounts to be awarded is ninety thousand U.S. dollars (\$90,000.00). In accordance with IRS rules, the value of each prize may be treated as income to the winner, and the winner may be responsible for reporting of income and payment of all applicable federal, state, and local taxes. If applicable, an IRS Form 1099 will be issued to each Prize Winner for the total amount of the prize in the calendar year the prize was won. If the prize is merchandise, the stated Actual Retail Value (ARV) of the prize is based on available information provided to Sponsor and any difference in ARV at the time of awarding will not be awarded

**VI. PRIZE WINNER SELECTION:** Odds of winning a prize will depend on the total number of eligible entries received. Nine (9) Prize Winners will be randomly selected from all valid entries received. The Drawing will be conducted at the Credit Union's Headquarters in Fort Worth, Texas, at the close of business on Oct. 12, 2026. Need not be present to win. Winners will be notified by phone, email, or mail. If a winner cannot be contacted within five (5) business days of the initial contact date or refuses the prize after being contacted, the prize will be forfeited and awarded to an alternate winner. Upon initial notification and verification of each Prize Winner, confirmation will be sent to the Prize Winner via email, U.S.P.S. mail or other home delivery service of Sponsor's choice.

**VII. PRIZE TERMS AND CONDITIONS:** All properly claimed prizes will be awarded. Each Prize Winner may be required to provide additional documentation and is required to comply with any and all applicable federal, state and local laws, rules and regulations. Except as prohibited by applicable law, each Prize Winner will be required to sign an Affidavit of Eligibility and Liability/Publicity Release and provide valid identification (collectively, the "Prize Acceptance Release"), and return it within five (5) business days of written notification or the prize will be forfeited and an alternate potential winner selected. If a prize or prize notification is returned as unclaimed or undeliverable to a potential winner, if potential winner fails to return requisite documentation within the specified time period, or if a potential winner is not in compliance with these Official Rules, then such potential winner shall be disqualified and an alternate winner will be selected for the prize at issue. To claim a prize, each Prize Winner will be required to provide his or her first name, last name, mailing address, telephone number and email address. Each potential winner may be subject to verification of eligibility before a prize will be awarded.

The Sponsor reserves the right at its sole discretion to substitute any prize (or prize component) with another prize (or prize component) of equal or greater value. Prize may be fulfilled by a third party. The Sponsor and Released Parties are not in any way responsible or liable for damages resulting from shipping and handling, loss, use or misuse of any prize awarded in this Drawing.

The Prize Winner's acceptance of a prize constitutes permission (except where prohibited) for the Sponsor to use the Prize Winner's name, photograph, likeness, statements, biographical information, voice and address (city and state) for any and all public relations, advertising and/or promotional purposes as determined by Sponsor, in all forms of media and by all manners (now and hereafter known), for a period of one (1) year from the end date of the Promotion Period, without notice, consent, review or approval or further compensation.

**X. GOVERNING LAW/DISPUTES:** Except where prohibited, Participant and Prize Winners agree that: (1) any and all disputes, claims and causes of action arising out of or connected with this Drawing or any prize awarded shall be resolved individually, without resort to any form of class action, and any judicial proceeding shall take place in a federal or state court in the County of Tarrant, Texas; (2) any and all claims, judgments and awards shall be limited to actual out-of-pocket costs incurred, including costs associated with entering this Drawing, but in no event shall costs incurred include attorneys’ or legal fees; and (3) under no circumstances may Participant obtain awards for, and Participant hereby waives all rights to claim, indirect, punitive, incidental and consequential damages and any other damages, other than for actual out-of-pocket expenses,
